Franz called the meeting to order at 1:28 p.m. on Wednesday, December 13, 2017 in room 324 of the Student Union. Franz announced the UCCC Chair election will be held at the January UCCC meeting. Nominations may be made by email to Jenny Turner by 5:00 p.m. on Wednesday, January 17, 2018. The election will be held on Friday, January 19th at the UCCC meeting. Franz also updated the committee on UCCC software and form revisions. Revisions have been made to the software, so deletions of courses now have a shorter workflow, and additional approval is no longer necessary to offer a course during Maymester. Franz also announced she will be meeting with Dr. Peter Ryan, Associate Provost for Academic Affairs, about further revisions to the UCCC software and form revisions.

Hunt moved to approve the November 17, 2017 minutes. Coyne seconded the motion. The minutes were approved unanimously. A committee member pointed there may need to be more detail in the minutes concerning syllabi issues.

Stewart moved to approve the modification of the BA in Music. Hunt seconded the motion. The subcommittee that reviewed the proposal recommended approval of the modification. A committee member pointed that the proposal indicates the revisions to the curriculum will not increase potential placement of students or increase the salaries of graduates. A committee member was also concerned about the wording of some of the Justification and Learning Outcomes in the proposal. Dr. Richard Human appeared in support of the proposal. Dr. Human indicated the Justification and Learning Outcomes in the proposal are aligned to the national accrediting body. Dr. Human also indicated he would be glad to revise the proposal concerning potential student placement and salaries for graduates. Parajuli moved to pass the modification of the BA in Music contingent upon the above concerns being addressed. Perkins seconded the motion. The motion to pass the modification of the BA in Music contingent was approved unanimously.

Stewart moved to approve the modification of the Minor in English and the addition of the Minor in Creative Writing. Parajuli seconded the motion. The subcommittee that reviewed the proposals recommended approval. The motion to approve the modification of the Minor in English and the addition of the Minor in Creative Writing was approved unanimously.

Kirkland moved to approve the addition of GR 4783 Satellite Meteorology. Stewart seconded the motion. The motion to approve the addition of GR 4783 was approved unanimously.

Parajuli moved to approve the addition of AEC 4803/6803 Applied Quantitative Research. Stewart seconded the motion. The subcommittee that reviewed the proposal suggested there needs to be a clear distinction between what is required of undergraduate students and graduate students. The subcommittee also suggested the sentence in the proposal concerning how grades will be curved needs clarification. Phillips moved to pass AEC 4803/6803 Applied Quantitative Research contingent upon the above concerns being addressed. Campbell seconded the motion. The motion to approve the addition of AEC 4803/6803 Applied Quantitative Research contingent was approved unanimously.

Parajuli moved to approve the modification of AEC 8123 Analysis of Agricultural Markets. Stewart seconded the motion. The subcommittee that reviewed the proposal recommended approval. A committee member pointed that the sentence in the proposal concerning how grades will be curved needs clarification. Franz indicated she would mention it to the initiator. The motion to approve the modification of AEC 8123 Analysis of Agricultural Markets was approved unanimously.

Parajuli moved to approve the modifications of the MS in Agricultural Economics (Thesis) and the MS in Agricultural Economics (Non-Thesis). Hunt seconded the motion. The subcommittee that reviewed the proposals recommended their approval. The motion to approve the modifications of the MS in Agricultural Economics (Thesis) and the MS in Agricultural Economics (Non-Thesis) was approved unanimously.

Parajuli moved to approve the Authorization to Plan and the Addition of the MS in Agriculture: Animal and Dairy Science, Entomology, Plant Pathology, and Poultry Science. (The Request to Add Distance Education to the program was withdrawn from the agenda.) Hunt seconded the motion. The motion to approve the Authorization to Plan and the Addition of the MS in Agriculture: Animal and Dairy Science, Entomology, Plant Pathology, and Poultry Science was approved unanimously.

Parajuli moved to approve the modifications and addition of distance education to BCH 4603/6603 General Biochemistry I and BCH 4613/6613 General Biochemistry II. Hunt seconded the motion. Committee members pointed out that the Campus 5 syllabus grading scale indicates that the grade of F is equal to or less than 60 while it should indicate the grade of F is less than 60. Franz indicated she would pass that information along to the initiator. The motion to approve the modifications and addition of distance education to BCH 4603/6603 and BCH 4613/6613 was approved unanimously.

Roussin moved to approve the modification of the BACC in Accountancy. Hunt seconded the motion. The subcommittee that reviewed the proposal recommended approval. The motion to approve the modification of the BACC in Accountancy was approved unanimously.

Roussin moved to approve the modification of the MTX (Master of Taxation), the modification of the MPA (Master of Professional Accountancy), the modification of ACC 8033 Assurance and Audit Data Analysis, and the modification of ACC 8043 Fraud Examination and Data Analysis. The subcommittee that reviewed the proposals pointed out that for the program proposals the hours required for the Graduate Minor in Business Analytics need to be clarified; for ACC 8033 the subcommittee noted AOP 12.09 should be mentioned in relation to attendance, contact hours greater than 3 should be broken down in the course outline, the course objectives are the same as the course description; and the subcommittee had no concerns about ACC 8043. Parajuli moved to pass the modification of the MTX,

the modification of the MPA, the modification of ACC 8033, and the modification of ACC 8043 contingent upon the above concerns being addressed. Coyne seconded the motion. The motion to pass contingent was approved unanimously.

Campbell moved to approve the addition of a minor in Civil Engineering. Hunt seconded the motion. The subcommittee that reviewed the proposal led a discussion about the wording used for a student to request a minor, whether a student could take more than one track, and whether the track would be posted on the transcript. The motion to approve the addition of a minor in Civil Engineering was approved unanimously.

Committee members recognized Pam Sullivan, who is retiring on December 31, 2017, for her years of service to the UCCC

Hunt moved to adjourn the meeting. Parajuli seconded the motion. The motion to adjourn was approved unanimously. The meeting was adjourned at 2:45 p.m.

JUSTIFICATION AND STUDENT LEARNING OUTCOMES

Justification

The proposed modification is designed to provide students necessary coursework while <u>reducing the number of hours</u> in the program to more closely align with MSU guidelines as well as leading academic programs in the discipline outside of MSU. The proposed modification is also designed to <u>align the required coursework</u> with that of other leading academic programs in the discipline. According to the Graduate Catalog, "Mississippi State University requires that doctoral students earn at least 54 hours of graduate credit beyond the bachelor's level, which includes a required 20 hours of dissertation credits." The current program requires 76 hours, and those hours are generally beyond the master's level. So, students will often have over 100 hours of graduate coursework upon completion of this program. In addition, much of the coursework required that is taught outside of the College of Education is not coursework required by other leading academic programs in the discipline.

Student Learning Outcomes

Student learning outcomes are not changing as material in deleted courses is included in current coursework or in coursework offered in other programs in our department that we propose to add to the curriculum. In addition, the proposed changes will address concerns voiced by our program advisory committee.

Competencies related to *CCL 8383 Ethical Decision Making* are located in **CCL 8153 Human Resources**, a course that is currently part of our Master of Science in Workforce Education Leadership degree program. They are also located in other courses being taught in the program including CCL 8333 Community College Administration, CCL 8283 Leadership in Community College Administration, and CCL 8233 Community College Legal Issues.

Competencies related to *EDA 8323 Educational Facilities Design* are located in other courses being taught in the program including CCL 8333 Community College Administration and CCL 8123 Community College Finance.

Competencies related to PPA 9613 Rural Government Administration I and PPA 9623 Rural Government Administration II as well as AEC 6353 Introduction to Regional Economic Development, AEC 6323 Applied Region Economic Development, and AEC 8713 Rural Community Economic Development will be addressed in CCL 8343 Community Development and Resources, a course generally taught by a long-time community college administrator and currently part of our Master of Science in Workforce Education Leadership degree program.

Competencies more specific to higher education than those in *PPA 8733 Public Program Evaluation* are located in **HED 8673 Planning and Institutional Research in Higher Education**, a course that is currently part of our PhD in Educational Leadership Higher Education Leadership concentration.
