Belli called the meeting to order at 2:00 pm in Lloyd-Ricks Annex, north end.

Wolverton moved, seconded by Palmer, to approve the minutes of the November 20, 2003 meeting. Nicodemus mentioned that she was present at the November meeting but had not been listed. The correction was noted, and the motion passed unanimously.

Belli introduced Brocato from Curriculum and Instruction and DelPrince from Plant and Soil Sciences.

Bridges moved, seconded by Chamblee, to approve the modification of the Bachelor of Science, Horticulture, Retail Floristry Management Concentration and the addition of PSS 2343 Floral Design as a Fine Art Core Course. After extended discussion, the motion passed unanimously.

Chromiak moved, seconded by Wolverton, to approve the addition of Advanced Planning and Managing Learning, EDS 8883 Dimensions of Learning I, and EDS 8893 Dimensions of Learning II. After discussion, the motion for the courses passed, with one opposed, and approval of EDS 8243 contingent upon receiving a letter of support from the Counselor Ed and Ed Psychology department.

Jones moved, seconded by Chromiak, to approve the addition of the Master of Arts in Teaching, Secondary Teacher Education degree program. After discussion, Wolverton moved, seconded by Chamblee, to table the degree program pending revision by Kay Brocato. The motion to table passed unanimously.

Chamblee moved, seconded by Bridges, to approve the addition of HI 4333/6333 Native

Henington moved, seconded by Wolverton, to approve the addition of EPP 2213 Introduction to Insects as a Natural Sciences Core Course.
