Belli called the meeting to order at 2:20 p.m. (after a short delay necessary to reach a quorum) in Lloyd-Ricks Annex, north-end.

Henington moved, seconded by Bryant, to approve the minutes of the February 21, 2002 meeting. The motion to approve the minutes passed unanimously.

Henington moved, seconded by Palmer, to approve the addition of the Certificate in Geospatial and Remote Sensing Engineering, and the Certificate in Geospatial and Remote Sensing Applications. Chuck Hill was asked to provide an overview of the proposed certificate programs. After discussion, the motion to approve the programs was passed unanimously, contingent upon reformatting the course requirements to improve clarity.

Henington moved, seconded by Wolverton, to approve the course proposals, and the program modification proposal (B.A., Music Education) submitted by the Department of Music Education. Course deletion proposals included: MU 1161 Survey of Musical Styles, MU 1214-1224 Theory, MU 2213 History and Literature of Music I, MU 2214-2224 Theory, MU 4322 Band Arranging, MU 4332 Choral Arranging, MU 4412 Vocal Literature, MUE 3523 Instrumental Methods and Materials, MUE 3533 General Music Methods and Materials, MUE 3543 Coral Methods and Materials, MUE 3612 Introduction to Music Education, and MUE 4511 Introductory Marching Band Techniques. Course modification proposals included: MU 1111-1121 Piano Class, MU 3111-3121 Piano Class, MU 3333 Orchestration, MU 3442 Instrumental Conducting and Literature, MUE 3211 Brass Techniques, MUE 3221 Woodwind Techniques, and MUE 3242 Percussion Class. Course addition proposals included: MU 1162 Survey of Music Styles, MU 1213-1413 Music Theory I and Music Theory II, MU 1321-1521 Ear Training I and Ear Training II, MU 2111-2121 Piano Class, MU 2322 History and Literature of Music I

Education, and MUE 3213 Performance Assessment in Music Education. Michael Brown (Dept. Head, Music Education), was asked to provide an overview of the proposed changes in the Music Education curriculum. After discussion, the motion to approve the course proposals, and the degree program modification was passed unanimously, contingent upon receipt of course topic outlines for MU 2613-2813 Music Theory III and Music Theory IV.

Bridges moved, seconded by Wolverton, to approve the addition of PSS 8646 Field Application of Weed Sciences Principles I, and PSS 8656 Field Application of Weed Sciences Principles II. A concern was raised that the program descriptions were very similar, differing only in the plant species listed. An additional concern was that the hours listed in the topic outlines did not match the credit hours in the course description. After discussion, the motion was passed unanimously, contingent upon changing the course numbers to PSS 8645, and PSS 8655, and revising the hours in the catalog description for both courses to read "Three hours lecture. Four hours laboratory."

Bumgardner moved, seconded by Bridges, to approve the modification of ABE 4312 Biosystems Environment II, the addition of ABE 4323 Physiological Systems in Biomedical Engineering, the deletion of ABE 4821/6821 Practices in Engineering Design, and the modification of Engineering degree program (B.S., Agricultural and Biological Engineering). The motion passed unanimously.

Bridges moved, seconded by Palmer, to approve the modification of FO 3012 Introduction to Forest Communities, FO 3014 Forest Description and Analysis, FO 4221-6221 Practice of Silviculture Laboratory, FO 4223/6223 Practice of Silviculture, FO 4232-6232 Forest Operations and Harvesting, FO 4311/6311 Forest Photogrammetry Laboratory, FO 4312/6312 Forest Photogrammetry, and the degree program (B.S., Forestry). The motion passed unanimously.

Bridges moved, seconded by Althen, to approve the course proposals and the degree modification proposal (B.S., Wildlife and Fisheries Science) submitted by the Department of Wildlife and Fisheries. Addition proposals included: WF 4121 Wildlife and Fisheries Biometrics Laboratory, WF 4122 Wildlife and Fisheries Biometrics, WF 8124 Research Methods in Wildlife and Fisheries Science, WF 8154 Quantitative Applications in Wildlife Population Ecology, WF 4453/6453 International Cultures and Natural Resources Mgt. The single course mofidication proposal included in the motion was WF 8144 Wildlife Population Dynamics. After discussion, the motion to approve the course proposals, and the degree program modification was passed unanimously, contingent upon changing the course number of WF 8124 to WF 8134 to avoid confusion with a recently deleted course.

Wolverton moved, seconded by Henington, to deny the request by the Department of Wildlife and Fisheries to use the newly added course WF 4453/6453 International Cultures and Natural Resources Management to satisfy a core requirement in the Humanities category. After discussion, the motion was passed unanimously.

Bumgardner moved, seconded by Palmer, to approve the deletion of CVM 8583 Wildlife and Pharmacology and Toxicology. The motion was passed unanimously.
