Chamblee called the meeting to order at 3:05 p.m. in the Billie Nowlin Conference Room in Lloyd Ricks. Bridges moved, seconded by Palmer to approve the minutes of the April 21, 2006 meeting. It was noted that Charles Palmer should have been excused from the April meeting. The motion passed unanimously.

Chamblee introduced Dean Jim West from Architecture, Art, and Design, and Dr. Robert Zullo from the Department of Kinesiology.

Bridges moved, seconded by Ebanks, to approve the addition of CVM 8552 Foreign and Emerging Animal Diseases. The motion passed unanimously.

Bridges moved, seconded by Henington to remove from the table and approve the addition of BCS 2116 Construction Design Studio I-A, BCS 2126 Construction Design Studio I-B, BCS 3116 Construction Design Studio II-A, BCS 3126 Construction Design Studio II-B, BCS 4116 Construction Design Studio III-A, BCS 4126 Construction Design Studio III-B, BCS 3213 Electrical Systems, BCS 3323 Future Systems, and BCS 4223 Professional Practices, and the addition of a Bachelor of Science in Building Construction Science degree, and the change to the C.I.P. number for the BBS in Management of Construction and Land Development. Dean West addressed the concerns of course and program duplication and other general questions the committee had raised at the April meeting. He explained the unique aspects of the program. The motion passed unanimously.

Bridges moved, seconded by Henington, to remove from the table and approve the modification of PE 8123 Physical Education and Sport Programs, and PE 8823 The Sport Product, the deletion of PE 8213 Problems in Administration of Athletics, the addition of PE 8881 Sport Administration Practicum and the modification of the Master of Science in Physical Education-Sport Administration concentration. Dr. Zullo answered several questions about the program and the requested changes to courses. The committee was very concerned with course requirements for selling sponsorships. It was suggested that

the Sport Administration program get approval from Dean Mike White, Student Life, for selling sponsorships. After lengthy discussion, Palmer moved, seconded by Lehman, to table all the proposals. The motion to table the course and degree proposals passed unanimously.

Bridges moved, seconded by Ebanks, to approve the addition of CHE 3331 Professional Development, the modification of CHE 2213 Chemical Engineering Analysis, the deletion of CHE 1231 Design Concepts in Chemical Engineering, and the modification of the Bachelor of Science in Chemical Engineering degree. The motion passed unanimously.

Bridges moved, seconded by Henington, to remove from the table and approve the addition of a Master of Engineering for distance learning. The motion passed unanimously.

Bridges moved, seconded by Henington, to remove from the table and approve a modification to the Bachelor of Science in Agricultural Pest Management (degree name change). The motion passed unanimously.

Bridges moved, seconded by Bourgeois, to adjourn at 4:40.
