Chamblee called the November 18, 2009 meeting to order at 2:00 in Room 325 of the Union. Wolverton, moved, seconded by Palmer, to approve the October 15, 2009 meeting minutes. The motion passed unanimously.

Science in Forestry. A question was raised about the correct name for FO 4353/6353 and FO 4443/6433. Schultz indicated that department that the course titles had been changed earlier. The motion passed unanimously.

Schultz moved, seconded by Palmer, to approve the modification of FO 8293 Master of Forestry professional Paper. The motion passed unanimously.

Dixon moved, seconded by Memili, to approve the AOCE offering of GR 4473/6473 Numerical Weather Prediction, GR 4823/6823 Dynamic Meteorology I, GR 4933/6933 Dynamic Meteorology II, FR 4943/6943 Tropical Meteorology, GR 8573 Research in Applied Meteorology, GR 8613 Hydrometeorology, GR 8633 Climate Change, GR 8813 Advanced Hazards and disasters, GR 8833 Weather and Society, and the addition of a concentration in Applied Meteorology to the Master of Science degree in Geosciences. The motion passed unanimously.

Carr moved, seconded by Wolverton, to approve the AOCE offering of PSY 3213 Psychology of Abnormal Behavior, PSY 3353 Motivation, and PSY 3363 Behavior Modification. A question was raised about the target audience for the courses. Armstrong explained the department wanted to offer the courses through AOCE in hopes of identifying who might be interested in take these types of courses. The motion passed with one no vote.

Thompson moved, seconded by Wolverton, to approve the AOCE offering EM 4213/6213 Advanced Mechanics of Materials. The motion passed unanimously.

Wolverton moved, seconded by Thompson, to approve the addition of AIS 8413 Methods of Planned Change in Agricultural and Extension Education. The motion passed unanimously.

Palmer moved, seconded by Wolverton, to approve the modification to PSS 4314/6314 Soil Microbiology and BIO 4324/6324 Soil Microbiology. The motion passed unanimously.

Palmer moved, seconded by Wolverton, to approve the addition of CO 3591 Auditioning/Monologue. The motion passed unanimously.

Dandass moved, seconded by Schultz, to approve the addition of CSE 1002 Introduction to CSE. The motion passed unanimously.

Dandass moved, seconded by Palmer to approve the modification and AOCE offering of IE 3124 Industrial Ergonomics, and the addition and AOCE offering of IE 3121 Industrial Ergonomics Laboratory. The motion passed unanimously.

Dandass moved, seconded by Schultz, to approve the modification of the Bachelor of Science degree in Computer Science and the Bachelor of Science degree in Software Engineering. The motion passed unanimously.

Thompson moved, seconded by Palmer, to approve the addition of the Doctor of Philosophy degree in Industrial and Systems Engineering. The motion passed unanimously.

Wolverton moved, seconded by Palmer, to remove PSS 8553 Plant Growth and Development from the table. Following discussion the original motion to approve the addition of PSS 8553 passed unanimously.

Wolverton moved, seconded by Palmer, to remove EP 8433 Psychological Aspects of Exercise, EP 8443 Neuromuscular Mechanisms in Exercise, PE 8203 Psychological Aspects of Sport, EP 8453 Biomechanics of Human Movement, and SS 8203 Funding of Sport. Following discussion the original motion passed unanimously.

Palmer moved, seconded by Bourgeois, to adjourn at 3:45 p.m.
