The Master of Arts in Special Education (MA.T.X) is an alternate route licensure program of study that consists of 33 semester hours of graduate-level coursework that is designed for a person seeking a career as a special education teacher. In addition to the criteria for admission to a Master of Science degree program in CISE (with the exception of a teaching license), M.A.T.X. candidates must pass the Praxis Core and Praxis II Specialty Areas Test required for special education licensure by the Mississippi Department of Education and pass a certified background check.

The Master of Arts in Special Education (MATX) is an alternate route licensure program of study that consists of 30 semester hours of graduate-level coursework that is designed for a person seeking a career as a special education teacher. In addition to the criteria for admission to a Master of Science degree program in CISE (with the exception of a teaching license), MATX candidates must pass the Praxis Core (or meet the ACT requirement of a score of 21 or higher) and Praxis II Specialty Areas Test required for special education licensure by the Mississippi Department of Education and pass a certified background check.

3. JUSTIFICATION AND STUDENT LEARNING OUTCOMES

A. Justification

The MATX program is an alternate route teacher certification program that allows for candidates to gain certification as well as seek a degree. The program is one of two alternate route teacher certification programs authorized by the Mississippi Department of Education (MDE) with special education (K-12) as an initial licensure area. The MATX program consists of 27 hours of special education coursework, a three-hour reading pedagogy elective, and a three-hour math pedagogy elective. The math and reading pedagogy electives were included in the program of study because many children with special needs struggle in the areas of math and/or reading. The two options for the math pedagogy elective include EDE 8163 Teaching Middle Level Mathematics Content and EDS 6633 Mathematics Education Pedagogy. The classes were developed for other alternate route programs for regular education teachers and they do not meet the needs of students in the MATX program. Therefore, it is the recommendation of the secondary special education faculty to remove this requirement.

The only other Master of Arts in Teaching program with special education as an initial licensure area is at William Carey and they do not have a math pedagogy in their program of study.

B. Student Learning Outcomes

The MATX program is designed to prepare non-traditional students to become K-12 special education teachers. The MAT-X program prepares teacher candidates to be effective educators. Each professional preparation course produces learning outcomes that give the candidate the knowledge and skills to create a positive learning environment, develop and implement individualized education

plans, make data-based decisions using both informal and formal assessment, intervene with evidence based practices to increase student progress toward the general curriculum.

 - 1. Will the program change/meet local, state, regional, and national educational and cultural needs? If so, please describe.

Yes, the program will meet MDE requirements for the certification of alternate route teachers.

2. Will the program change result in duplication in the system? If so, please describe.

The MATX faculty and staff strive to recruit diverse students who will become special education teachers. The removal of the math pedagogy elective will make the program more cost effect and help in the recruitment of diverse students.

4. Will this program change/result in an increase in the potential placement of graduates in MS, the Southeast, and the US?

The change will increase the number of MATX applicants and increase the number of special education teachers in Mississippi. Special education is a critical needs subject area and Mississippi faces a shortage of special education teachers every year.

5. Will this program change/result in an increase in the potential salaries of graduates in MS, the Southeast, and the US? If so, please describe.

School districts pay teachers based on level of degree and years of experience. By completing an advanced degree through the MATX program, teachers will receive an increase in salary.
